## Nominee Qualifications

*Per WVMA Constitution: Article XII - Elections, Section 13*

To be eligible for nomination to any WVMA board position, the nominee must meet the following membership requirements:

### **Board of Trustee:**

Must have been a WVMA member for **three consecutive years** immediately prior to the current year  
(Required years: 2023, 2024, 2025, 2026)

### **Board of Directors:**

Must have been a WVMA member for **at least one year** immediately prior to the current year  
(Required years: 2025, 2026)

### **Term limits:**

An individual may not serve on the same board for more than **two consecutive terms**, even if one or both terms were incomplete. They may run again for the same board **after a one-year break**.

Note: Service on the **Board of Trustees or Board of Directors in a non-presidential role does not count** toward the term limit of the President position

## Position Descriptions

### Board of Trustees:

The governing body of the association. The Board is responsible for acquiring, purchasing, or renting real estate properties for the Association, as well as handling legal, tax, and insurance matters related to the Association

### Board of Directors:

The Board of Directors is responsible for the day-to-day operations of the Association. They work under the direction of the President and report directly to the Board of Trustees.

## Nomination Requirements & Declarations

### 1. Eligibility to Nominate:

To be eligible to nominate, you must have been a WVMA member on or before **April 10, 2026**, by midnight. By signing this document as a Nominator, you verify that:

The nominee is eligible and qualified for the designated position.

The nominee has no conflict of interest.

The Election Committee may request verification of your WVMA membership eligibility to nominate or second a nominee. Please note that each nominee requires two nominators.
